Chairman of the Wyoming County Board of Supervisors, Jerry L. Davis reports as of earlier today, Tuesday, June 02, the Wyoming County Health Department reports eighty-two (82) lab-confirmed positive cases of COVID-19 among Wyoming County residents. That is an increase of two (2) cases since the last reported increase on Monday, June 01.
