Chairman of the Wyoming County Board of Supervisors, Jerry L. Davis as of earlier today, Wednesday, June 24, the Wyoming County Health Department reports eighty-seven (87) lab-confirmed positive cases of COVID-19 among Wyoming County residents. That is an increase of one (1) from the last reported increase on Tuesday, June 23.
