Chairman of the Wyoming County Board of Supervisors, Jerry L. Davis, reported as of earlier today, Thursday, July 2, the Wyoming County Health Department reports eighty-nine (89) lab-confirmed positive cases of COVID-19 among Wyoming County residents. That is unchanged from the last reported increase on Monday, June 29.
