Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan, reports, as of earlier today, Thursday, October 22nd, the Wyoming County Health Department reports one hundred eighty-three (183) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of two (2) cases from the last reported increase on Wednesday, October 21, 2020.
