Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Friday, January 8, 2021, the Wyoming County Health Department reports one thousand three hundred seventy-eight (1,378) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of thirty-nine (39) cases from the last reported increase on Thursday, January 6, 2021.

From the New York State Department of Health: If you are in the priority population per the NYS Vaccination Program Phase 1A guidelines, you are currently eligible to be vaccinated.

Eligible individuals must sign a statement and provide proof of eligibility at the vaccination clinic (i.e. a paystub or employer issued ID tag).

Additional clinics will be scheduled in the near future based on supply of vaccine.
