**The Wyoming County Health Department will be offering FREE
COVID-19 rapid tests for those who live or work in Wyoming County**

**The next community testing event will be held Wednesday, January 27th
Details and registration information will be announced by Wednesday, January 20th**

THIS IS NOT A VACCINATION CLINIC

From the New York State Department of Health: If you are in the Phase 1A or 1B Priority Population according to the NYS Department of Health ["Phased Distribution of the Vaccine"](#) guidelines, you are currently eligible to receive a COVID-19 vaccination.

The Wyoming County Health Department COVID-19 will schedule vaccination clinics when additional vaccine is received from New York State. Registration will be online when clinics are scheduled, the Health Department cannot take reservations over the phone. Check back frequently at www.wyomingco.net for updated information. It is expected that more locations in Wyoming County will receive vaccine directly from New York State in the coming days and weeks to vaccinate those that are eligible.

It may take up to three months to vaccinate everyone eligible in Phases 1A and 1B based on supply of vaccine.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Tuesday, January 19, 2021, the Wyoming County Health Department reports one thousand six hundred sixty-two (1,662) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of twenty-three (23) cases from the last reported increase on Monday, January 18, 2021.
