From the Wyoming County Department of Health:

If you are in the Phase 1A or 1B Priority Population according to the NYS Department of Health ["Phased Distribution of the Vaccine"](#) guidelines, you are currently eligible to receive a COVID-19 vaccination.

Beginning this week, adults of any age with certain pre-existing conditions will also be eligible for a COVID-19 vaccination. The Health Department has been allocated 200 doses of Moderna COVID-19 vaccine this week; a clinic will be scheduled upon receipt of vaccine and according to the most recent guidance from NYS. Continue to check www.wyomingco.net for clinic availability.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Tuesday, February 16, 2021, the Wyoming County Health Department reports two thousand twenty-seven (2,027) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of thirty-four (34) cases from the last reported increase on Friday, February 12, 2021.
