**NEW:** A few appointments remain for the Pfizer COVID-19 vaccination clinic on Tuesday, March 9<sup>th</sup> at Wyoming County Highway for **residents of Wyoming County, ages 65 years and older only.**

**Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan** announced as of Monday, March 8, 2021, the Wyoming County Health Department reports two thousand one hundred seventy (2,170) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of eighteen (18) cases from the last reported increase on Friday, March 5, 2021.
