From the Wyoming County Department of Health:

NEW: There will be a COVID-19 Moderna vaccination clinic on Wednesday, March 10 from 12:30pm to 4:00pm at the Wyoming County Highway Department. According to New York State, this clinic is only for essential workers in Priority Population 1B and adults with certain pre-existing conditions per NYS Guidance "Phased Distribution of the Vaccine". Essential workers being vaccinated must bring proof of eligibility to the vaccination site. This could be an employee ID card, a letter from an employer or affiliated organization, or a pay stub.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Tuesday, March 9, 2021, the Wyoming County Health Department reports two thousand one hundred eighty (2,180) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of ten (10) cases from the last reported increase on Monday, March 8, 2021.
