**From the Wyoming County Department of Health:**

**NEW:** The NYS Department of Health released a “*Health Advisory: Quarantine for Community Persons Exposed to COVID-19*”. The update describes how to factor in a person’s vaccination status following a community exposure to COVID-19. In summary, consistent with recent CDC guidance, asymptomatic individuals who have been fully vaccinated against COVID-19 do not need to quarantine following exposure during the first 3 months after full vaccination, subject to certain criteria. **NEW:** The NYS Department of Health released “*Interim Guidance for Quarantine Restrictions on Travelers Arriving in New York State Following Out of State Travel*”. The update describes how to determine quarantine status following travel out of New York State, factoring in a person’s vaccination status and/or previous infection with COVID-19 in the last 3 months, subject to certain criteria. Governor Cuomo announced that domestic travelers will no longer be required to quarantine after entering New York from another state or U.S. Territory starting April 1, 2021.

**Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan** announced as of Thursday, March 11, 2021, the Wyoming County Health Department reports two thousand one hundred ninety-one (2,191) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of seven (7) cases from the last reported increase on Wednesday, March 10, 2021.
