From the Wyoming County Department of Health:

NEW: There will be a COVID-19 Moderna vaccination clinic for Wyoming County residents on Thursday, March 18 from 8:45am to 4:00pm at the Wyoming County Highway Department. According to updated guidance from New York State, this clinic is for anyone currently eligible for COVID-19 vaccination per NYS Guidance "Phased Distribution of the Vaccine". Essential workers being vaccinated must bring proof of eligibility to the vaccination site. This could be an employee ID card, a letter from an employer or affiliated organization, or a pay stub. If you are not a resident of Wyoming County, do not register - you will not be vaccinated.

According to the New York State "COVID-19 Vaccine Tracker" website ([HERE](#)), 19.5% of Wyoming County residents have at least one COVID-19 vaccine dose (NYS average is 22.9%). Local officials are advocating for more doses to be allocated to Wyoming County.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Tuesday, March 16, 2021, the Wyoming County Health Department reports two thousand two hundred thirty (2,230) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of three (3) cases from the last reported increase on Monday, March 15, 2021.
