Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Thursday, March 18, 2021, the Wyoming County Health Department reports two thousand two hundred forty-two (2,242) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of five (5) cases from the last reported increase on Wednesday, March 17, 2021.
