**Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan** announced as of Friday, March 26, 2021, the Wyoming County Health Department reports two thousand two hundred eighty-six (2,286) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of four (4) cases from the last reported increase on Thursday, March 25, 2021.
