Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Tuesday, April 20, 2021, the Wyoming County Health Department reports two thousand four hundred seventy-nine (2,479) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of four (4) cases from the last reported increase on Monday, April 19, 2021.
