Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Thursday, April 22, 2021, the Wyoming County Health Department reports two thousand five hundred one (2,501) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of fifteen (15) cases from the last reported increase on Wednesday, April 21, 2021.
