Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Tuesday, April 27, 2021, the Wyoming County Health Department reports two thousand five hundred fifty-six (2,556) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of seven (7) cases from the last reported increase on Monday, April 26, 2021.
