**PRESS RELEASE**  
**April 30, 2021**

**Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan** announced as of Friday, April 30, 2021, the Wyoming County Health Department reports two thousand five hundred ninety-nine (2,599) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of seventeen (17) cases from the last reported increase on Thursday, April 29, 2021.
