**Still need a COVID vaccine?**

- There is a walk-in COVID Johnson & Johnson community vaccination clinic on Thursday May 20, 2021 from 1:00pm to 3:00pm. The clinic will be at the First Congregational Church (Perry Center) at 7209 State Route 20A in Perry. This will be the single dose Johnson and Johnson COVID-19 vaccination for anyone 18 years and older. Bring identification and proof of insurance to the clinic. If you are uninsured, there is no charge for the vaccine administration. Call the Health Department at 786-8890 with questions.

**NEW:** If you are a Wyoming County resident unable to get to a community vaccination location (because of illness, disability, age, or transportation difficulties), please call NY Connects Wyoming County at 786-8833. A nurse will then contact you and schedule a time to come to your residence to vaccination you and your caregiver / family members.

**Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan** announced as of Thursday, May 13, 2021, the Wyoming County Health Department reports two thousand six hundred eighty-seven (2,687) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of seven (7) cases from the last reported increase on Wednesday, May 12, 2021.
