Those over age 18 in need of a COVID-19 vaccine can visit the next **walk-in single-dose Johnson & Johnson COVID-19 community vaccination clinic**:

Monday, May 24, 2021 from 4:00pm to 6:00pm at St. Michael's Roman Catholic Church at 171 North Main Street in Warsaw. The clinic will be at the Schafer Center (next to the church on North Street). A FREE hotdog, bag of chips and drink will be provided by St. Michaels with each COVID vaccination!

Please bring identification and proof of insurance. If you are uninsured, there is no charge. Call the Health Department at 786-8890 with questions.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Friday, May 21, 2021, the Wyoming County Health Department reports two thousand seven hundred thirty-two (2,732) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of six (6) cases from the last reported increase on Thursday, May 20, 2021.
