**NEW:** Wyoming County residents in need of a COVID-19 vaccine but unable to leave their homes due to illness, disability, age or transportation issues can call NY Connects Wyoming County at 786-8833 to be placed on the Homebound Roster. A nurse will then contact you to schedule a time to come to your home to administer the Johnson & Johnson COVID-19 vaccine to you, your family members/caregiver.

**Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan** announced as of Tuesday, May 25, 2021, the Wyoming County Health Department reports two thousand seven hundred forty-eight (2,748) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of sixteen (16) cases from the last reported increase on Friday, May 21, 2021.
