With vaccination rates increasing, COVID-19 activity is declining statewide and many restrictions have been lifted in New York State (visit [HERE](#) for more information on current guidelines). Wyoming County will be issuing situational updates weekly. Call the Health Department with specific questions at 585-786-8890.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Friday, July 2, 2021, the Wyoming County Health Department reports two thousand seven hundred sixty-eight (2,768) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of two (2) cases since the last reported increase on Thursday, June 24, 2021. There are two (2) laboratory-confirmed active COVID-19 cases in Wyoming County as of today.
