**Vaccination Registration** can be done online by visiting: [www.wyomingco.net](http://www.wyomingco.net) and selecting the “COVID-19 vaccination” *Quick Link*. Registration is open for **Moderna, Pfizer, J&J/Janssen, or Booster\* dose vaccine** at the Wyoming County Health Department on:

**October 29<sup>nd</sup> from 9:00AM to 3:00PM**  
**November 3<sup>rd</sup> from 9:00AM to 3:00PM**  
**November 5<sup>th</sup> from 9:00AM to 3:00PM**

Moderna and J&J/Janssen vaccine is for anyone 18 years and older. Pfizer vaccine is for anyone 12 years and older. Children under 18 must be accompanied by a parent or guardian that can provide consent. Please bring identification, proof of insurance and vaccination card if you are receiving a Booster dose. If you are uninsured, there is no charge. Call the Health Department at 786-8890 with questions or if you need assistance registering.

\*At this time and in accordance with CDC guidance, the following groups of New Yorkers **should** receive their COVID-19 booster vaccine at least 6 months after their initial Moderna/Pfizer series and at least two months after the initial J&J vaccination:

- New Yorkers 65 years and older or residents in long-term care settings,
- New Yorkers aged 50–64 years with underlying medical conditions.

The following groups of New Yorkers **may** receive their COVID-19 booster vaccine dose:

- New Yorkers aged 18–49 years with underlying medical conditions, based on their individual benefits and risks,
- New Yorkers aged 18–64 years who are at increased risk for COVID-19 exposure and transmission because of occupational or institutional setting, based on their individual benefits and risks.

It's recommended you get the same vaccine manufacturer you received initially, but it's OK to mix-and-match any of the three kinds.

**Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan** announced as of Thursday, October 28, 2021, the Wyoming County Health Department reports three thousand five hundred eighty (3,580) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. There is an increase of sixty-five (65) cases since the last reported increase on Thursday, October 21, 2021. There are currently fifty (50) laboratory-confirmed active COVID-19 cases in Wyoming County.

**The Centers for Disease Control characterizes COVID community transmission in Wyoming County as “High” between October 20 and October 26, 2021.**

The CDC recommends wearing of face masks for vaccinated and non-vaccinated individuals indoors and in public settings. The community is strongly encouraged to promote behaviors that prevent spread and maintain healthy environments, such as cleaning high touch surfaces, ensuring clean ventilation systems, and allowing for social distancing.
