The Wyoming County Health Department is providing COVID-19 testing on Mondays, Wednesdays and Fridays. Testing will be “drive through” style at the Wyoming County Highway Department located at 4328 Route 19, approximately 4 miles south of the Village of Warsaw. **Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan** announced as of Thursday, December 16, 2021, the Wyoming County Health Department reports four thousand seven hundred eighty-three (4,783) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of one hundred sixty two (162) cases since the last reported increase on Thursday, December 9, 2021. There are currently one hundred forty seven (147) laboratory-confirmed active COVID-19 cases in Wyoming County.
